Telephone response to Scoping from Gas Networks Ireland.

13th October 2017

James O'Keefe called the McCarthy Keville O'Sullivan office via telephone on the 13th October 2017 regarding the scoping letter he received for the proposed River Bride (Blackpool) Certified Drainage Scheme. He confirmed that they had no infrastructure in the area of the additional works (i.e. in the area of the two drawings appended to the scoping letter). James recommended that the 'Dial Before you Dig' line was called before the project commences to ensure there is no risk. They can provide details of any services in the area if they are required.

James also noted that this scoping letter (and any future scoping letters) would be best sent to the following address:

Thank you for the clarification.

From an IFI viewpoint in-stream works should be limited to the period May to September inclusive and ideally would not involve any excavation below the waterline as it exists when the work is taking place. IFI would ask to be consulted in advance of any such proposed works. All necessary measures should be taken to avoid tracking in-stream or contamination of downstream waters with solids or other materials

Hi Michael,

Many thanks for your email.

Maintenance activities are likely to consist of the following:

The channels and structures will be monitored by means of a walkover survey from the banks on a regular basis (likely quarterly, and also following a flood event). The walkover surveys would aim to identify issues with implications for flood risk (e.g. fallen trees, excessive vegetation build-up, overgrown trees, illegal dumping, accumulation of granular deposits, etc.). In-channel debris will typically be removed by JCB. Excessive overhanging vegetation will typically be pruned back or removed by hand using a cherry-picker, depending on access.

I hope this is of help in clarifying the point, and please feel free to let me know if you have any other questions.

Separate structure approvals/permits and other licences may be required in connection with the proposed haul route and all structures on the haul route should be checked by the applicant/developer to confirm their capacity to accommodate any abnormal load proposed.

Notwithstanding any of the above, the developer should be aware that this list is non-exhaustive, thus site and development specific issues should be addressed in accordance with best practise. I hope that the above comments are of use in your EIAR preparation.


There are badger, fox and otter and heron documented along this stretch.




