Why a flood relief scheme?

The purpose of this **Flood Relief Scheme** is to lessen the effects of flooding and to protect the community of **Ballina - Killaloe** against future flood events. The aim is to provide a scheme that is technically, socially, environmentally, and economically acceptable.

Tipperary County Council has appointed Engineering and Environmental Consultants Ayesa Engineering (previously ByrneLooby) to design and implement the proposed **Flood Relief Scheme**.

Tipperary County Council will be working with the Office of Public Works to deliver the project

On **Thursday 12th June 2025 at the Lakeside Hotel, Ballina from 2pm-7pm**, we are hosting a public engagement event for the project to present the findings of the assessments undertaken, to outline the option being developed to alleviate flooding and to obtain the views of the public stakeholders on those options.

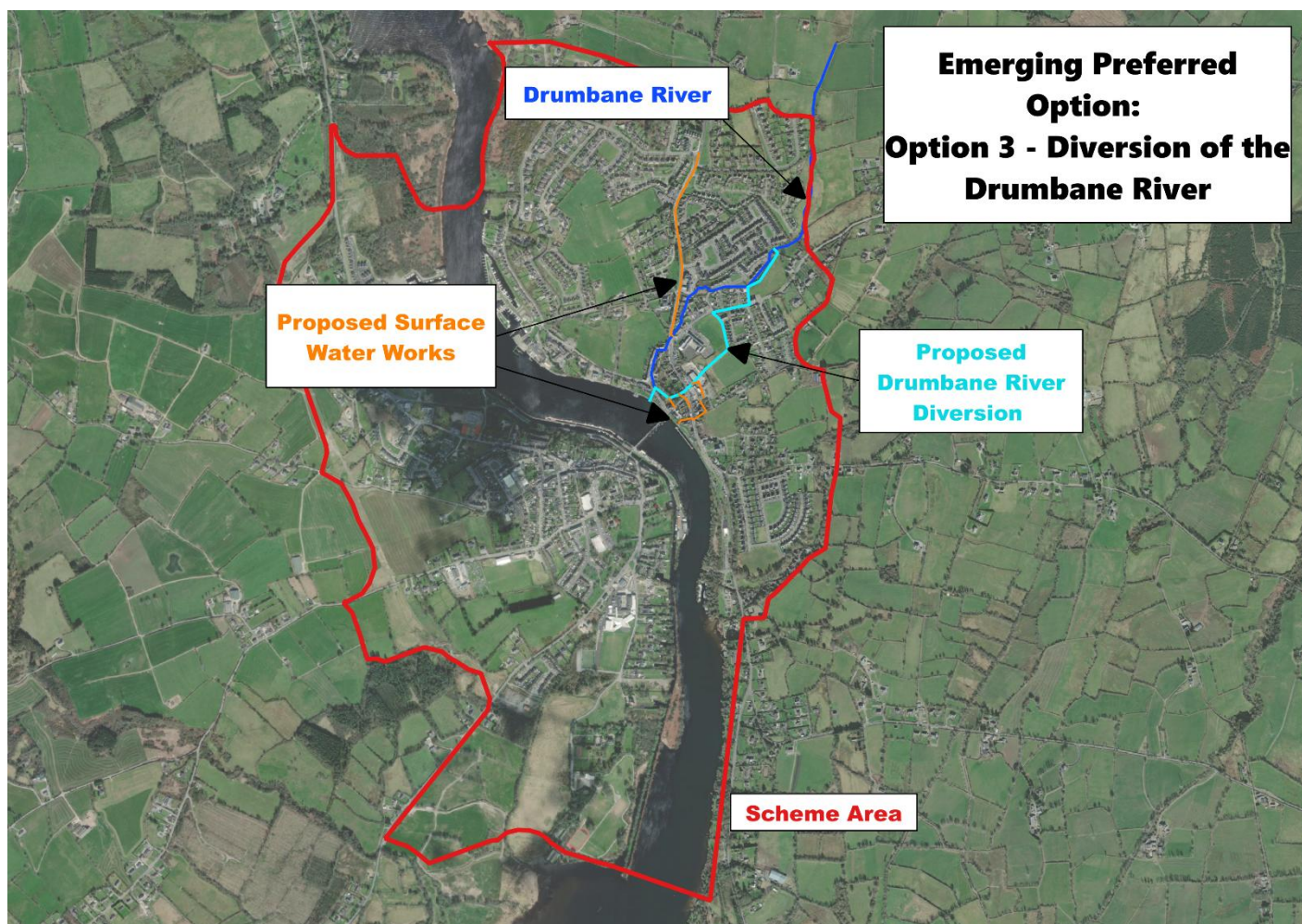
