
### **Purpose of the Project**

The purpose of the Graiguenamanagh-Tinnahinch Flood Relief Scheme is to alleviate the risk of flooding to the Community of Graiguenamanagh-Tinnahinch by providing a scheme that is technically, socially, environmentally and economically acceptable.

Kilkenny County Council have appointed ByrneLooby to undertake the design and implementation of the proposed Flood Relief Scheme. Kilkenny County Council will be working together with the Office of Public Works and Carlow County Council to deliver the project.
