ROADS ACT, 1993

TEMPORARY CLOSING OF PUBLIC ROADS

Pursuant to Section 75 of the Roads Act, 1993, and Article 12 (6), in Part 8 of the Roads Regulations 1994, notice is hereby given that the urgent closure of the road as detailed below is necessary, in the interests of public safety.

Road Subject of Urgent Closure

L-2964 New Line Road, Brooklodge, Glanmire, Co. Cork.

Period of Urgent Closure

From 06:00hrs on Thursday, 31st October 2024 to 18:00hrs on Friday, 28th March 2025 (24hr Closure).

Reason for Urgent Closure

To facilitate construction of New Line Bridge and Associated Reinforced Concrete Walls for the Glanmire Flood Relief scheme.

Alternative Routes

Approaching from Glanmire on the L-2966 continue past the turn for the L-2964 and take the next Left on to the L-7022 continue to the T junction turn left on to the L-2964.

The stated diversion route is applicable in reverse when travelling in the opposite direction.

Local access will be maintained throughout the duration of the Road Closure.

You should note that this Urgent Closure does not facilitate the making of objections/observations.
