BACKGROUND TO THE STUDY

Portarlington is at risk of flooding, with numerous properties and businesses currently at risk from the River Barrow and its tributaries.

Binnies UK and Nicolas O'Dwyer Joint Venture have been commissioned to develop the Portarlington Flood Relief Scheme working on behalf of Laois County Council and in partnership with Offaly County Council and the Office of Public Works.

The Project Team hosted two public consultation events in the past. The last Public Consultation Day was held in November 2022, where two emerging flood relief options were presented. Since then, we continued to advance Stage I of the Scheme by completing the following activities:

- Options analyses—this included a cost benefit analysis and multi-criteria analysis which supported the option selection process of the preferred Scheme,
- Environmental and Ecology surveys—to inform the relevant Assessments of the Scheme and determine any mitigations measures which may be required to minimise the Scheme's impact,
- Identified and designed a Scheme which will provide flood relief for the 1% AEP (1 in 100-year return period) fluvial flood event.


