## **Purpose of the Project**

The purpose of the Tipperary Bundle 2 - Ballina–Killaloe Flood Relief Scheme is to alleviate the risk of flooding to the Communities of Killaloe and Ballina (due to flooding from the *Grange stream* and *Drumbane river* identified on the map below) by providing a scheme that is technically, socially, environmentally and economically acceptable.

Tipperary County Council have appointed ByrneLooby to undertake the design and implementation of the proposed Flood Relief Scheme. Tipperary County Council will be working together with the Office of Public Works to deliver the project.

This is the first public engagement event for the project; its objective is to gather information from the public about their experiences of flooding in the Scheme Area along with their thoughts on possible solutions to the flooding problem and their preferences in this regard. Local experience, knowledge and insight is an essential prerequisite for any successful Flood Relief Scheme.
