Kilkenny County Council in partnership with Carlow County Council and The Office of Public Works (OPW) are advancing with the Graiguenamanagh-Tinnahinch Flood Relief Scheme, (GTFRS) as abbreviated within the Newsletter.

Stage 1

Stage 2

Stage 2 is the Planning and Development stage.

Planning Process

The route to obtain statutory approval to construct the scheme will be via a Part 10 Planning Application to An Coimisiun Pleanála under Sections 175 and 177AE of the Planning & Development Act, 2000 (as amended) for the construction of the GTFRS.

The new Planning & Development Act 2024 is not expected to come into effect until sometime in 2026, and it is envisaged that the scheme will be submitted prior to its implementation. The legislation allows for ACP to make decisions on applications under the old act once the new act comes into law.

The Compulsory Purchase Order Application to ACP will be submitted concurrently with the Planning Application for the FRS.
